

## REACH COMPLIANCE DECLARATION

REACH requires all companies manufacturing or placing a substance on the EU market in quantities greater than 1MT/year to register that substance with the European Chemicals Agency (ECHA). For legal reasons, only companies with a legal entity in Europe can submit a registration under REACH, however, non-EU companies may submit REACH registration by appointing an Only Representative to register on their behalf, in which case, their importers will be regarded as downstream user and do not need to do registrations.

THE EUROPEAN PARLIAMENT AND THE COUNCIL OF EUROPEAN UNION  
CONSIDER THE FOLLOWING:

(41)

*For reasons of workability and because of their special nature, specific registration requirements should be laid down for intermediates. **Polymers** should be exempted from registration and evaluation until those that need to be registered due to the risks posed to human health or the environment can be selected in a practicable and cost-efficient way on the basis of sound technical and valid scientific criteria.*

Furthermore, in Chapter 1, Article 2, number nine estates:

*9. The provisions of Title II and Title VI shall not apply to Polymers. Being Title II Registration of Substances and Title VI Evaluation.*

Article 138 Review, declares:

- 1. By 1 June 2019, the Commission shall carry out a review to assess whether or not to extend the application of the obligation to perform a chemical safety assessment and to document it in a chemical safety report to substances not covered by this obligation because they are not subject to registration or subject to registration but manufactured or imported in quantities of less than 10 tons per year.*
- 2. The Commission may present legislative proposals as soon as a practicable and cost-efficient way of selecting polymers for registration on the basis of sound technical and valid scientific criteria can be established, and after publishing a report on the following:*

*(a) the risks posed by polymers in comparison with other substances;*

*(b) the need, if any, to register certain types of polymer, taking account of competitiveness and innovation on the one hand and the protection of human health and the environment on the other.*
